Proceedings of Town Trustees Meeting held in the Town of Springfield

The Board of Trustees of Springfield Township met May 13th, 2020 at the Township Administration Building at 3298 Terminal Ave, Springfield, IL.

Present: Supervisor Gary Budd, Trustees, Shannon Lynch, Don Willett, Mike Morris, Arthur Watts, Clerk Robert Remack, Road Commissioner Ron Smith. Excused: Assessor Cinda Sausaman, Collector Janine Stroble.

Meeting called to order at 6:00 p.m. by Supervisor Gary Budd.

The Treasurer's report and minutes of the Board Meeting of April 14, 2020 were reviewed. A motion was made by Arthur Watts and seconded by Mike Morris to accept the treasurer's report and approve the minutes. All voted aye. Motion carried.

Bills were submitted to the Town Board for authorization to pay. A motion was made by Mike Morris and seconded by Shannon Lynch that said bills be authorized for payment. All voted aye. Motion carried.

UNFINISHED BUSINESS: \$845.00 was deposited in the dumpster fund in May. \$170.00 was collected on the first Saturday of the month.

NEW BUSINESS: A motion was made by Mike Morris and seconded by Arthur Watts to pass the Town Budget Ordinance#2020-2021-01 in the amount of \$298,509.00. An individual voice vote was taken. All voted aye. Motion passed.

A motion was made by Shannon Lynch and seconded by Arthur Watts to pass the Road District Budget Ordinance#2020-2021-02 in the amount of \$317,563.00. An individual voice vote was taken. All voted aye. Motion passed.

A motion was made by Mike Morris and seconded by Arthur Watts to authorize approximately \$5,500.00 for the food giveaway scheduled for Saturday, May 23, 2020. All voted aye. Motion carried.

Supervisor Gary Budd reported due to the pandemic real estate tax payments will not be collected by the Township Collector's office this year. Payment should be made directly to the County.

Supervisor Gary Budd reported interested parties will be able to attend, by remote assess, the Sangamon County Zoning Board Public Hearing at the Township Administration Building at 7:00 p.m., Thursday, May 21, 2020 concerning the zoning case by Joe Chernis, Jr. involving property on Sandhill Rd.

Motion to adjourn was made by Mike Morris and seconded by Shannon Lynch. All voted aye. Motion carried.
